

Mental Capacity Act.

This Act comes into place in April this year. The Act aims to empower and protect vulnerable people who may not be able to make decisions for themselves.

The current system of Enduring Power of Attorney will change. However, anyone who has an existing Enduring Power of Attorney in place will be protected. Those who do not will have to register under the new system- this could cost as much as £150 for registration and up to £800 per annum for 'close supervision cases' (as with all legislation full definition is vague).

Therefore, I strongly advise you that if you do not have an Enduring Power of Attorney in place, do so before the end of April as the costs are considerably less.

FEE INCREASES

Unfortunately it is that 'time of year' again when we will be notifying you of fee increase and sending you new Standing Order mandates.
